Scott Toland – Explained that he was a volunteer for the 805AgKids and stated that between August 5th and August 13th 805AgKids rented facilities at the fairgrounds to conduct the first ever Independent Junior Livestock Show and buyer's BBQ to wrap up the auction. He explained what 805AgKids is all about, how they are supported and some details of the event. He expressed his concerns about not being heard through recent communications with staff and the Board regarding participating in specific discussions and planning involving the future of the ag kids in the community.

Karen Peters – Introduced herself as the Co-Chapter Leader of Ventura County Brady United and explained how the 19th DAA, Earl Warren Showgrounds, posts their agenda/consent list and compared it to the way the Ventura County Fairgrounds is done. She commented that on the consent agenda for the meeting today there is an October gun show listed and she is anxious as to how the board is going to vote on this. She suggests that Board members who are voting for a gun show should not try and hide it on the consent agenda. She suggests voting against the gun show at the fairgrounds.

Mr. Yepez gave a report on the financials ending July 31st, 2021.

Director Weigel asked what the year-to-date total revenue is for CBF Productions.

President Cornejo asked Mr. Yepez to send that information to CEO Quaid so she can email it to the full board.

VIII. Old Business

A. 2022 Ventura County Fair

CEO Quaid stated that once the Board schedules the Recovery and Organizational Planning Meeting, which will be in the beginning of fall, staff and the Board will be able to incorporate the timeline and the hiring of employees into that planning process. Staff is working internally on items as far as when to hire employees, what departments are critical to the operations of the fairgrounds, what services need to be bid, etc.

President Cornejo commented that CEO Quaid has assured her that a timeline is being created for the timely hiring. The Board needs to have an informed meeting with all the correct facts to determine the dates, where we fit in with all the contractors and suppliers, etc. to make it more productive. There are no intentions to delay this. She reminded everyone that their meetings are governed by Bagley-Keene, and they are not meetings where the public is doing the discussion or votes, but public comments are valued, and all meetings are opened to the public. Discussions or suggestions outside of the meetings should be directed to staff so they can be included. She stated that she is happy to meet with anyone individually at their request, but the board must take great care under Bagley-Keene that anytime more than two directors involved in decisions or discussions on fairgrounds matters is a violation of state law. Therefore, meetings are open to the public to hear any discussions or votes that are being made.

There was discussion that pursued.

President Cornejo asked CEO Quaid, on behalf of the Board, at the next board meeting to have as much information that can be given on the 2022 Fair.

Director Long asked that if the board voted against the gun show would the board already be legally contracted to have the show; he would like a legal opinion on this.

Ms. Pelle stated that it would be recommended before a vote is made by the board, and given the history, that it needs to be reassessed to prevent litigation. She recommended a review of policy instead of the contract itself if there is going to be a change.

MOTION: To table the gun show until the next board meeting, if it is acceptable to management in terms of what they need to accomplish, so that in the interim the board can explore some of the legal issues that may be involved.

President Cornejo asked staff for a review in policy because it may take that to keep us legally protected before the board approves or does not approve the contract.

CEO Quaid stated that the gun show was brought to this meeting to allow for enough time for discussion in case it needed to be tabled. As she explained, there is a bill pending that would prohibit gun shows on state property.

Director Cuevas is not in favor of putting this item on the consent agenda, it should be an item that should always stand on its own so that it gets full community input.

President Cornejo commented that the policy changes were made by Director Cuevas' motion and finalized in June 2019. There will be some considerations with the issues of discrimination against specific vendors or suppliers. So, the board needs to analyze those issues, and this would be one reason why it would be great if the legislation would do the work for us as we only try to follow the law and protect ourselves by doing so. We do not want to target any one vendor or industry because that does leave us open to litigation and that is why it needs to be taken with great care as to how it is handled and voted on.

Director Cuevas stated that President Cornejo is absolutely correct and the focus on this one issue is very critical in the community and there are a lot of people watching this and that is another reason it shouldn't be within a consent agenda, it should always stand on its own.

Director Bradbury agreed with Director Cuevas.

CEO Quaid commented that on the agenda where it describes the consent agenda it says "unless an item is pulled for separate consideration" and that is exactly what the board is doing.

President Cornejo stated the board is going to be very careful with this and will process with great care and it will be on the next agenda.

XII. CEO Report

- Scheduling for the Fair is one thing she has been working on and what she has done so far has to do with our contractors, when we need to start booking acts, etc. Things are going a little backwards now and some of our contractors are holding on before they give us an absolute commitment for a start date.
- She was asked to do a report on the Foundation's brick program and during this summer there have been six bricks sold. Usually, people will come to an event at the fairgrounds and see the bricks in the courtyard and purchase one. She encouraged anyone who hasn't bought a brick to buy one or she can provide more information if needed. The money goes directly to the Foundation which is in support of the fairgrounds.
- Summerfest went very well and was very successful. We were able to make a good sum of money from them for twelve days with the parking, percentage of rides and food, etc. so we were very pleased with that.
- The 805AgKids event was well received. She attended the market show and everyone was enthusiastic and happy that they were down there.
- We are still selling parking passes and are at about 477 now so people are utilizing that beach parking lot.
- She received the deposit check from the folks that are leasing the Derby Club. That will be put into LAIF, which is a reserve savings account up in Sacramento. The Derby Room is hoping for a September 1st opening date.
- She met with the folks from the card club who are looking to possibly bring it to the Derby Club. She is only having the initial conversations now so there is not much to report. Once she has more information she will bring it to the board.

XIII. President's Comments

- Assured the public that it is the intent of the board to have a Fair next year. There is a long explanation of her comments in the minutes of last month's board meeting if anyone wants more detail as to the board's intent and reason why it takes nearly a year to put on a Fair that accepts around 300,000 people, trains 1000 volunteers and hires hundreds of part time employees; it is not something that you can just drop and do.
- We were thrilled to have Summerfest. Kastl Amusements did rent our facility to put on their program so that we could have at least a semblance of some activities this year for everyone.
- Pleased from everyone and all the events we have had as well as long term contracts that we have coming in the future including the Derby Room, Surfer's Pint and Surfer's Point.

XIV. Director's Comments

Director Cuevas

• Thanked CEO Quaid for her continued support that she is lending the Fair. She knows she is asking a lot of her and the limited staff but sees continuous comments from the public that they want to help. There is a huge constituent base who want to volunteer that are available and want to be involved and she thinks that public needs to see sooner rather than later some assemblance of a schedule and ongoing activities, so they know we are working on a Fair in 2022. There needs to be messaging and communication to the public letting them know that Summerfest was not an activity of the Fair it was an interim event that we were able to gain revenue from. Also, letting them know that in order to put on a Fair you have to be fully staffed. She thinks it is simply a lack of communication to the public on what our current situation is and we need to get our information out there.

Director Weigel

In the spirit of our commitment and assurance to our community she had a couple of observations to share. As a reminder to the board, she has been a volunteer for the 805AgKids starting in late February and speaking directly to her fellow directors it was a rude awakening. She was really troubled and frustrated in realizing that the community feels like they are not being heard. She spoke to a lot of individuals who just want to talk and have a true desire to want to help; they want to know what it is going to take to participate and support the Fair. She also commented that Spectra was wonderful on the day of their bidder's BBQ. It was great to see how the community all came together and all those individuals that showed up, as well as Kent with Old Country Butcher. Her question to the board and staff is what can we do differently that we haven't done before that is going to make the community truly feel that they have a voice and that there is a method. She understands Bagley-Keene but doesn't want to keep doing the same thing because it isn't working. She feels like the community is becoming more fractured and knows that none of the directors want that. So, her two observations were one, can the chat comments/questions be published in the minutes to show that that board is being open and building trust and confidence. Secondly, she recommends either bringing it to the Executive Committee or having it come from CEO Quaid, but for everyone to know who is volunteering and why we say yes or no to it.

It does not mean that the community gets to decide whether we say yes or no, but they would be assured and know that these offerings are out there.

Director Long

- It was a little dismaying to see the tone of the comments today and it needs to be worked out a little bit better.
- Thanked CEO Quaid and all the staff who has been working hard with all that is going on because it has not been easy.
- Thanked Mr. Lockwood for the letter he produced in response to the general plan that is going on with the City of Ventura which was brought up at the last meeting. He shared it with the general consultant that is working on this plan. The letter reminded everyone of how important the fairgrounds is to the safety and well-being of our county as well as that it is state property and not something for the City to try and rearrange or plan for.
- We are having a little downturn again but hopes that things get better and won't prevent the fairgrounds from making all these other plans.

Director Bradbury

- Stated that he wanted to echo most comments and emphasize what President Cornejo said and that is that the board is committed to having a Fair but it is important that we assure its financial success and that it is safe for the public. Those are our primary responsibilities that everyone should understand and that we are as committed to having a Fair just as much as anyone else subject to those two concerns.
- Echoed Director Weigel's comments because he has had the same input and it is extremely important that we listen to the public because the board is their representatives. The board needs to pay better attention and there are a lot of areas where the board can be more helpful in that regard.
- Thanked CEO Quaid and staff. She has labored under extraordinary circumstances, reduced budget, staff and everything else and still seems to keep a substantial presence and gets the job done.
- From Twin Falls, Idaho he wishes everyone a great day and hopes everyone stays safe.



Ms. Quaid and Ventura County Fair Board members:

Well, you did it again. You tried to sneak in the gun show contract and dates into the consent agenda. Special thanks for Directors Cuevas and Bradbury for stopping this breach of protocol and common sense.

I do not want sales of guns and ammunitions at the Ventura County Fairgrounds. I realize this may have a financial impact on your bottom line, but the Fair Board has had considerable time (11/2018 = nearly three years) to come up with alternatives. Yet you have not.

Before you change any language in the gun show dealer's contract, along with any terms and conditions, I would suggest the fair board review its past inquiries with Ventura County law enforcement agencies, as well as contacting the District Attorney's office. Please ask each about where guns used in crimes have been coming from (including ghost guns). I am interested in actual data from each department not a comment from one police chief in this County saying "nope, no guns from the fairgrounds." I believe the DA's office would have considerable data available as well. Data is key to modern-day law enforcement. Data doesn't lie. Please get the data.

As for ghost guns - unserialized, do-it-yourself kits that produce guns that are untraceable - the ABSOLUTE LEAST you



can do right now is not allow ghost gun sales at Ventura County Fairgrounds. They took up considerable space at the

Feb. 8, 2020 gun show I attended.

I am truly hoping that SB264 passes so we no longer have to look to you to make decisions about gun shows on State-owned land. I'm proud that our State Senator Monique Limón is a coauthor of this bill. Let me know if a meeting with Senator Limón would be helpful. I'm happy to assist.

And finally, my apologies for not attending regular Fair Board meetings during the pandemic. It's obvious that more Ventura County residents need to keep watch over business dealings and contracts. We're back at it.

My name is Timothy Heyne, a resident of the Santa Rosa Valley, Ventura County, and an advocate for safe & sensible gun laws.

A brief personal history. On Memorial Day, 2005, my wife and I, Jan, returned a boat we had borrowed back to my best friend, Steve Mazin, to his Thousand Oaks residence. While Steve, myself and Jan were talking in the driveway, a man whom Steve had an ongoing legal issue with came up the driveway to us, and at point blank range, pulled a 9mm Glock Semi-Auto pistol from behind his back, and shot all three of us multiple times. Jan and Steve died immediately and by the grace of God, I survived three gunshot wounds. The killer then went into hiding, killed another innocent, shot a law enforcement officer, and finally, blew his own brains out. Steve had a restraining order against the killer (who also had a very violent past) who shouldn't have had access to one firearm, let alone the three he had in his possession at the time of the murders.

Since that time I have been an advocate against the runamok gun violence culture that has engulfed our nation to the tune of 50,000 Americans killed annually by gunshot...which brings me to the insane ridiculousness of "Gun Shows". My heart sinks everytime I see one advertised, but none more than the annual nightmare at our own Ventura County Fairgrounds.

Despite what Firearm Supporters claim, Gun Shows and some of its merchants still illegally peddle wares, skip background checks, push conspiracy theories, etc., and do so all within the "Carnival" atmosphere found inside Gun Shows. We must be responsible to our children and grandchildren's futures and safety by eliminating these irresponsible opportunities for moving Ghost guns, the gun thefts from careless vendors, and all the other unlicensed conveyances of firearms that unfortunately occur all too often at these things and do little more than further America's gun thirst and gun violence.

I understand that the Fairgrounds Board Of Directors will be taking a vote late next month on whether to permit Gun Shows at the grounds going forward. I ask and pray that you and the other directors take a long look into your family's eyes before the vote, think of their lives and hopeful futures, and vote to keep these "Carnivals Of Death" from our beautiful Fairgrounds and their wanted legitimacy of existence by being there!

We understand that the September meeting of the Fair Board will include consideration of a request from Crossroads of the West Gun Shows to hold a gun show at our fairgrounds in October.

This is sent to express our opposition to any gun and ammunition sales at our State-owned fairgrounds.

Our country holds two appaling records among all the developed countries of the world: we own the most guns and we annually have the most deaths resulting from gun violence. Just five months into 2021, there were already over 310 mass shootings nationwide and over 17,000 lives lost to gun violence. We risk that gun violence will be normalized.

Gun shows serve as flea markets for firearms; this is where unlicensed, unregistered and illegal firearms can be obtained through secondary, temporary and largely unregulated, markets. According to research by leading policy organizations, gun shows often create the opportunity to circumvent gun safety laws and are a common venue for straw purchases and illegal gun transfers.

Gun shows also are a major conduit for the sale of ghost guns — gun precursor parts that can be assembled into a firearm. We hear that the most popular vendors at gun shows are those selling ghost-gun kits for Glock-like pistols and AR-15-style rifles. These ghost-gun parts may have no serial numbers and can be purchased with cash and carried off the premises without any background checks or licensing. These untraceable ghost guns have become a top concern for law enforcement. There is no reason for anyone outside of the military to have these combat-type weapons.

Gun shows are held for one purpose: to sell as many guns and as much ammunition as possible. And this has been deadly for California communities. We understand that the Fairgrounds needs revenue, but given the research showing that more guns lead to more gun violence, it is morally reprehensible for our state to continue to promote gun violence by allowing the sale of guns and ammunition on taxpayer-owned property.

"SB 264/Senator Min has now been enrolled and on the Governors desk and clearly represents the case to eliminate all gunshows on state-owned property. Over the past three years the Ventura county community has spoken in opposition to hosting/contracting for gunshows on this publicly owned property. You have heard concerns with the sales and rising access to "ghost guns" with even our law enforcement professionals objections to the proliferation of these unmarked guns. You have heard concerns with the open-ended sales of ammunition that is readily available at these shows, and often turns up at mass shootings and domestic violence incidents. You have heard young people objecting to these shows in our community, as being the antithesis to what a safe and valued neighborhood should be. Gun shows are also NOT the place where criminals get their guns. John Lott, president of the Crime Prevention Research Center, "Multiple surveys done of criminals find that virtually no criminals obtain their guns from gun shows."

More people are killed by auto accidents, blunt objects, knives, hands & feet - than they are by guns & rifles. Should we ban automobiles, blunt objects, knives, hands & feet? The object that criminals use to kill is nothing but the tool. The killer is the criminal using that tool irresponsibly. Guns do not kill - the people behind them do.

We need to change this completely misinformed, anti-gun culture. And part of the way to do that is to keep having gun shows at locations such as the Ventura County Fairgrounds. Gun shows provide a place where people can learn the facts about guns, how to be a responsible gun owner, what it means to own a gun & how to properly handle a gun. A place to get an education about guns in general. AND Educations, as always, is part of the answer.

With the surge in gun ownership this past years, the gun shows at the fairgrounds provide a much needed service to the community. In addition, the gun shows at the fairgrounds provide an income to the County that may not be replaced.

I urge the Board of Directors to vote to continue to have gun shows at the fairgrounds, to provide an opportunity for people of all ages to learn about responsible gun ownership and protect our 2nd Amendment rights.

SUBJECT: Required Construction Inspections

This letter is a reminder that construction plan review and construction inspections by a state designated authority are required for all construction projects at state District Agricultural Associations (DAAs), as well as construction projects at county and citrus fairgrounds that have any component of state funding.

State funds include, but are not limited to, monies from the Fair and Exposition Fund, the General Fund, California Authority of Racing Fairs programs, funds generated by the DAA, or other state appropriations. In addition, projects at DAAs supported with fair foundation/non-profit organization funds will require construction plan review and inspection.

The two state designated entities that can provide the required plan reviews and inspection services for fairs are the Department of General Services (DGS) and the California Fairs Financing Authority (dba California Construction Authority (CCA). CCA and DGS serve as the project field representatives and monitor projects for compliance with applicable codes and laws.

California Building Code, <u>Section 105.1</u>, requires any owner, or authorized agent, who intends to construct, enlarge, alter, repair, move, demolish or change occupancy of a building or structure, or to erect, install, enlarge, alter, repair, remove, convert or replace any electrical gas, mechanical or plumbing system, the installation of which is regulated by this code, or to cause any such work performed, shall first obtain the required plans and approvals.

To comply with this requirement, California fairs must:

Requirements for DAAs

 <u>State funded projects:</u> Construction plan review and construction inspections are required for all projects at DAAs.

- <u>Non-state funded projects:</u> Construction plan review and construction inspections are required for all projects at DAAs including those constructed fully, or partially, with donations and/or other non-state sources of funds or volunteer labor.
- <u>Fair foundation/non-profit funded projects:</u> Construction plan review and construction inspections are required for all projects at DAAs that are constructed fully, or partially, with funds or volunteer labor from the fair's non-profit foundation.

Requirements for County Fairs

- State funded projects: Construction plan review and construction inspections are required for all projects with state funding at county fairgrounds.
- Non-state funded projects: County fairs may, at their option, utilize CCA or a local authority to provide inspection services.

Requirements for Citrus Fairs

- <u>State funded projects</u>: Construction plan review and construction inspections are required for all projects with state funding at citrus fairgrounds.
- Non-state funded projects: Citrus fairs may, at their option, utilize CCA or a local authority to provide inspection services.

Construction plan review and inspection services are required as a benefit to the fairs to protect them from liability and to assist in achieving successful projects. If your fairgrounds is considering a construction project you should contact CCA or DGS in advance to arrange for plan review approval and construction inspection services.
