Hello to the VC Fair Board Members,

I am writing today in regards to the massive redevelopment proposed by the Pacific Sports Group for our cherished fairgrounds. I am a longterm resident of Ventura, as is my extended family and partner's family. We've seen Ventura grow and develop over the years, but always maintain its small community charm. In fact, my great uncle helped develop Pierpont to what it is today.

The proposal currently in question claims to want to "fix" the fairgrounds - but in reality, they want to tear it down and start from scratch, building on natural wetlands, restricting beach access for the community, and providing "entertainment" that doesn't resonate with the community, at all.

I see from the proposal there is a desire to "raise the clientele profile." Raising the clientele profile is the main desire of this development, and we have to ask - for what? The residents of Ventura will not get the access they deserve to their beaches, their fair, their raceway - all things we value and take pride in. Instead, we should be promoting developments that cater to the current clientele of the community and their desires. The community of Ventura has a long history of loving raceways, motorcycles, surfing, agriculture - all things the fairgrounds and surrounding area currently cater to. The Ventura Raceway is a beloved activity that draws hundreds of attendees every weekend through the summer and fall. Local residents race each weekend and can be cheered on by their local neighbors and peers. Surfers flock to C Street every single day and already have extremely limited parking access - but it's fame goes well beyond just our community. I know, as a daily surfer, I rarely venture to C Street due to the difficulty of access, but would visit if it was easier. If I, a longtime resident, cannot easily access my beaches without considerable fanfare, how will others access it later with even further restricted access and traffic? And the fair attracts local residents each and every year and should be protected and expanded. We, at the heart, are a farming community, and should continue to protect our fair as a relevant activity for the local community.

I find the idea of "raising the clientele profile" to be incredibly dismissive of the current community, our needs, and our quality of life. We don't need increased traffic in town - it's already increased an incredible amount within the last several years. Parking by the beach is already becoming increasingly challenging, especially during peak summertime. We don't need a further influx of tourists who will trash our beaches and make it impossible for LOCAL people to enjoy the fruits of our surroundings. And I have certainly never heard anyone clamoring for baseball or any semi-professional sports to be brought to Ventura - in fact, the general sentiment is keep those as far away in LA as possible, and keep the traffic and visitors *out*.

Additionally, the high cost of this project seems in total contradiction with the actual ongoing needs of the city. We need investment in keeping our beaches clean. We need investment in keeping our people SAFE. We need investment in helping and managing our ever-growing unhoused community. We need investment in bettering our water management systems, our fire preparedness, our farming communities. In fact, a development such as this would

threaten ALL of those efforts. Why exactly are we promoting an unnecessary, likely unprofitable development such as this during a recession with a city that is already at capacity?

The board has already voted NO on this proposal once before.

We - our community, the people of Ventura and Ventura County - urge you to listen to the people and save what matters to us. Save our fairgrounds, our history, our environment, and our community. Please don't let outside developers come in and ruin what is at the core of Ventura and its very devoted community.

Though racing history at the fairgrounds stretches back to 1924, my husband and I first heard about the raceway through an acquaintance and have since introduced friends who have then invited more friends. Dear BOARD OF DIRECTORS of the 31st District Agricultural Association,

The San Buenaventura Conservancy for Preservation is a non profit 501(c)(3) that works to increase public awareness of irreplaceable historic places and cultural sites, to disseminate information useful in the preservation of structures and neighborhoods, to prevent needless demolition, to champion adaptive reuse, and promote the preservation and enhancement of historic and cultural resources in Ventura and surrounding areas. What follows are the Conservancy's comments on the 'Project' to renovate the Ventura Seaside Park Fairgrounds with a new entertainment and sports stadium.

Any 'Project' to redevelop, enhance, make additions, and renovate structures for new uses at the Seaside Park Fairgrounds should be informed by proper environmental pre-planning. A survey of the extant cultural resources (and other environmental impacts) would inform the board and the public of potential impacts, allow for feasible alternatives to avoid impacts, and mitigate unavoidable impacts. 'Projects' that are designed while fully understanding the constraints and opportunities can integrate public benefits, enhance resources and avoid adverse impacts up-front, and are more likely to receive community support. Any unavoidable adverse impacts can be dealt with through the California Environmental Quality Act (CEQA) Environmental Impact Report (EIR) process which can impose mitigations to offset impacts.



The Canary Island Palm rows on both sides of "Seaside Park Main Street" through the middle of the Fairgrounds are potentially eligible for the National Register of Historic Places. Other structures in Seaside Park may be contributors to a "Ventura Seaside Park Historic District" and should be surveyed and evaluated by architectural historians.

Of particular importance is the presence of the prehistoric and Historical site of Shisholop which is within the immediate area of the fairgrounds. Shisholop is also where Juan Cabrillo first landed in Ventura and made contact with the Chumash who lived in the village. This archaeological site was subject to limited excavations in the 1960s and found burials, significant native American grave goods, religious items, and numerous artifacts. In 1969 a very small portion of the site was excavated and most importantly did not do a boundary test of the

known site. It is an important consideration that the mapped boundaries are only approximate and do NOT represent the actual boundaries which as of this date are still unknown.

If there is to be subsurface excavation as part of this project, then archaeological testing of the site would be necessary and critical and it should be noted that some Chumash cemeteries spread out the graves making them difficult to predict where they might be. This was recently found in excavations in Carpinteria where 7 burials were encountered in an isolated cluster with no other burials in the vicinity. It goes without saying that Native American participation would be critical to any project of this nature. A treatment plan should be prepared in advance and reviewed by other archaeologists and Native Americans prior to any excavations or other subsurface work and this would include any geological assessments. The EIR will also need to deal with the cumulative impacts to similar archeological resources in downtown with the increase of proposed development in the area.

Dear Ventura County Fairgrounds Board of Directors,

I am writing to you in response to the proposed sports and entertainment venue at the fairgrounds. Please consider the implications of building a stadium at the fairgrounds.

There are several compelling arguments against the construction of a stadium. First and foremost, the fairgrounds should remain a community asset, accessible to all. Eugene Foster, who donated the land for the fairgrounds, wanted it to be like Golden Gate Park: an open green space free for the people. We have fallen far enough from this vision already! (That said, I ADORE the annual fair and the swap meet. Last weekend, I went to the model train expo; it was great fun!) But a stadium would limit public access to the grounds and turn it into a private venue.

Building a stadium would require a significant investment of public funds, and the benefits are often overstated. While it is true that a new stadium may create jobs and generate tax revenue, these benefits may not be as significant as advertised. Economic activity and tax revenue generated by a new stadium are often redirected from other areas of the local economy rather than being created anew. The cost of supporting and maintaining a stadium would likely fall on taxpayers, creating a burden for future generations. Additionally, the jobs created by a new stadium are usually temporary, low-paying, and do not benefit the local community as a whole. It is essential to prioritize the community's needs over the desires of a few individuals or organizations. Ventura needs affordable housing, education, and healthcare – not minor league baseball games.

The fairgrounds belong to the community. They belong to local kids who present their gem & mineral collections. They belong to VC homemakers who display their baking skills and table-scaping artistry. They belong to flea marketers and weirdos that go to model train expos. Is Ventura currently home to a minor-league baseball team pining for a stadium? Please listen to the actual community's apprehension about economic impact, increased traffic, noise pollution, and potential environmental damage. In light of these concerns, I strongly urge you to reconsider the proposal to build a stadium at the fairgrounds.

Dear Ms. Lacayo and Members of the Board,

The Ventura County Fair is a valuable resource that is underutilized and in need of reinvestment. I assume that the 31st Agricultural District (Fair) does not have the money to plan and construct the needed improvements. A public/private partnership offers a way to get this done. On paper, the proposal from Pacific Sports Group (PSG) claims that it can construct a new stadium for minor league baseball and other activities, build new and expanded convention, retail and administrative headquarters space, upgrade the transit center, and provide for a police substation and more parking. These all sound like desirable improvements. But, before going further, I would recommend that the Fair do the following.

- 1. Explain to the community whether the Fair entered into discussions with PSG in accordance with State or local rules or regulations. If not, what was the process that should have been followed?
- 2. If the Fair needs to start over, I would recommend that it first identify all the goals for operation and improvements that it wants to see and include that information in its Request for Qualifications, or, if it enters into negotiations with PSG, that it use this information in its discussions. Has the Fair checked with other fairs in California to see what arrangements they may have made with private lessees? Has the Fair really researched best practices by other fairs?
- 3. Then, if the Fair has the authority to negotiate with PSG, or any other developer, I would ask the following:
 - a. That the Fair retain qualified legal counsel to thoroughly investigate and vet the background, experience, and financial resources of the developer. The Fair needs to be 100% confident that it will be dealing with ethical and experienced partners who can deliver what they promise.
 - b. That the Fair retain economic, architectural, appraisal and environmental consultants with experience in public/private partnerships to independently evaluate all the assumptions that are laid out in the developer's proposal, including construction costs, operating costs, and market potential of the events being planned. Are the lease rates, that the developer proposes to charge for use of the fairgrounds reasonable and achievable? What fee payments are expected of the Fair to the developer?
 - c. With the help of a qualified consulting team to advise the Fair's negotiators, that the relationship between the proposed public and private oversight entities be explained clearly. Who sets rental rates and fees for different activities? What activities will be allowed or prohibited? How will operations be audited? Which activities have priority? What is a reasonable return on investment for the developer and the Fair?

- d. The legal, economic, architectural, appraisal and environmental consultants that the Fair needs to hire to help it get through these negotiations will be expensive. If the Fair offers an Exclusive Negotiating Agreement to a developer, I would recommend that it receive from the developer payment of a sum sufficient for the Fair to pay its consulting team, with an arrangement made for repayment to the developer through future Fair revenue, should a deal be struck.
- The development review process will be subject to an Environmental Impact Report and Coastal Commission approval which may expose failings in the proposal or impose conditions to mitigate harm. The Fair can expect that negotiations will be iterative as the development plan is modified in response to these findings.

The Fair desperately needs a Master Plan. One was developed with the City of Ventura in the late 1980s, but never implemented. In the meantime, the bike path and parking along the shoreline have eroded and while improvements have been made, the facilities have become more outdated by the year. The Ventura County Fairgrounds is too valuable a community resource to allow it to continue to languish. The proposal from PSG has sparked my imagination of what the fairgrounds could become. My concern is that more information is needed so that the community can be confident that this is the right master plan and that this is the right private partner.

In general, I am concerned with the proposal for a number of reasons. First, the proposal may go against the intent of the Foster family who donated the property. Wikipedia states they *envisioned Seaside Park* as a miniature version of Golden Gate Park. The Fosters wanted a beautiful gateway to Ventura, where families could walk and picnic, play tennis, and enjoy family outings.

Although not specifically stated, I imagine hosting the Ventura County fair and now the Strawberry festival fits extremely well into this vision. I doubt their vision includes using the grounds for a convention center. I also question if they would have been supportive of the land having a major private influence that the PSG would have if approved.

Personally, I think the idea of having a minor league baseball team has been tried and shown to likely fail, especially in this location. However, the location has proven effective for hosting concerts.

To support the type of high utilization year round activities will pose a significant traffic issue in and around the area. If conventions are held there, lodging may be an issue.

I think the lease amount proposed is reasonable initially, but should have a COLA annual adjustment component to it as well as a percentage payment based on gross private receipts. I think any agreement that might be made would need ironclad performance guarantees such as the forfeiture of the private entity interest in the facilities if lease payments are missed.

I am concerned that any group who invests \$200 million plus will want too much control over the current and future direction of the property. For example, if and when the minor league baseball team fails, they will certainly have plans to make up for this lost projected revenue. If they have significant control, we may be at their mercy for what supplants it.

Convention Hall buildings can be quite tall as can parking structures. I cannot support any buildings in this area taller than the pavilions. The Derby Club is too tall in my opinion and any additional structures at that height or higher would detract from views of the coastline from scenic roadways.

In closing, since the Foster family envisioned family parks and tennis courts, adding a section of parkland including tennis courts (or pickleball courts as this is now extremely popular) would be welcomed. This section might be elevated to give it an excellent view of the ocean.

Dear Fair Board,

On February 22nd you will hear a presentation from Pacific Sports Group, a company that hopes to develop "entertainment villages" in the Hawaiian Islands. (It is difficult to determine from their website whether they have actually developed a project yet.) The fair board will see a concept plan for the Ventura County Fairgrounds property that consists of an area reserved for the Fair, a rodeo stadium and a baseball stadium with surrounding shops and other urban uses.

The fairgrounds exist on land originally deeded to the county for a public park by local philanthropist E.P. Foster. The fairgrounds sit on the Ventura River delta and have suffered from flooding and adjacent beach erosion over the decades. A significant concern raised by this proposal is the transformation of an at-risk area into an urban entertainment zone.

Phase II of the managed retreat is about to begin construction to establish a buffer zone of beach between the ocean and the fairgrounds. The eroded bicycle path will be moved away from the ocean, aligning it with the Phase I bike path. Phase I has worked as advertised to protect the beach and adjacent infrastructure through some very significant storms & high tides. This has been such a successful project that it is cited across the country as a premier example of how communities can protect their coastlines from the ravages of erosion and sea level rise.

Our obligation as a community is to plan for climate impacts, retreat where possible and mitigate. Adding more urban infrastructure to an area from which we know we need to be retreating is a step in the wrong direction. The Ventura River delta is a fragile area that we are working to protect through shoreline retreat and the removal of Matilija Dam. Adding more intensive urban uses to the area is in direct conflict with the community's long-term goals of coastal protection, shoreline retreat and to secure beach access to Surfers' Point.

Besides the concern that this might be the developer's first large project, I urge the fair board to reject this private urban concept plan for the fairgrounds property and to focus its efforts on less impactful uses for the fairgrounds, community beach access to Surfers' Point, coastal protection and the completion of Phase II of the managed retreat project.

To add to that, my son followed in my footsteps and when he was old enough to go with me, he did. When he was old enough to drive my car, I put him in it. Guest column: Let's not strike out chasing a Ventura County Fairgrounds stadium

Ventura County residents should walk away from a proposed stadium at the Ventura County Fairgrounds.

An out-of-town developer has pitched a mixed-use development there, the centerpiece of which would be a minor league baseball stadium. He says it would be transformative, but minor league teams only play around 70 home games per year, leaving a lot of days for a facility with limited cross purposes to sit idle.

It's bad enough that one developer managed to secure exclusive rights to possibly develop a prime piece of publicly owned real estate in coastal California, paying a paltry \$25,000. But what about his claim that the project would be entirely privately funded?

That sounds good, since taxpayer-funded stadiums are horrific wastes of precious taxpayer money. Yet across the country, millionaire and billionaire franchise owners have managed to shake down communities for massive amounts of subsidies. They often do so under threat — take the Oakland Athletics owner promising to flee to Vegas if he doesn't get hundreds of millions in public subsidies.

They also wave the banner promising jobs and prosperity. Yet there is a decades-long, evidence-based consensus among economists — conservatives and liberals alike — that stadiums are economic development losers.

One wide-ranging analysis of several such deals, by the non-partisan Brookings Institution, found sports facilities have not only a small but even a *negative* impact on economic activity and jobs. "No recent facility appears to have earned anything approaching a reasonable return on investment. No recent facility has been self-financing in terms of its impact on net tax revenues," write the authors of "Sports, Jobs, and Taxes: The Economic Impact of Sports Teams and Stadiums." "Regardless of whether the unit of analysis is a local neighborhood, a city, or an entire metropolitan area, the economic benefits of sports facilities are de minimus."

De minimus = little impact.

The reasons stadiums are not the economic generators their cheerleaders claim are common sense. Just because people have a new way to recreate doesn't mean they have more time or money to recreate, so a stadium simply transfers spending. Instead of going to a movie, you'll catch a game. Instead of eating downtown at Café Fiore, Peirano's or Rice by Mama, you'll check out the new restaurant by the water.

Existing businesses are hurt again, because the new ones are often subsidized, leaving existing establishments to compete against ones the government chose as winners.

J.C. Bradbury, a sports economist at the Kennesaw State University in Georgia, has similar findings to Brookings'. He and his co-authors speculated on the reasons why public subsidies are so endemic to sports facilities, despite their endless losing streak " and he and his co-authors looked at 30 years' worth of projects when they made their assessments.

As part of an explanation, Bradbury wrote: "Politicians and business leaders are predisposed to favor stadium projects because they are part of the cohort that will benefit the most from hobnobbing in luxury boxes and club seats with other local leaders and celebrities."

Let's remember, politicians love a good ribbon-cutting ceremony.

If the board opts to move forward and give the green light to a project that won't boost our regional economy, we need accompanying community benefits that we know will improve our lives, like housing units for our lowest-income earners, guaranteed set-asides for existing merchants in any new retail tenancy spaces, prevailing wage for construction workers, living wages and local first-source hiring for all the new jobs (minimum wage concession jobs isn't going to cut it), and green construction standards fenceline to fenceline.

It should not be given to the first man with the ability to pay a \$25,000 check.
