1. Junior Exhibitors will not be allowed to camp at the Ventura County Fair San Buenaventura State Beach camp area without a parent or guardian present at all times. The drinking of **alcohol is strictly prohibited**.
2. Move-in day will be Sunday, August 6, 2023, at a time designated by the Camping Manager. No exceptions.
3. All units must be removed no later than Sunday, August 13, 2023, by 10:00 PM. No exceptions.
4. No hook-ups are available. (Attachment to any facility fixture or equipment will be considered vandalism and subject to immediate loss of camping privileges.) Pumping service is available at cost per RV unit per service.
5. NO vehicles will be allowed in or out of the camping area after move-in is completed, until move-out begins. Violators may be subject to loss of camping privileges.
6. Number of spaces is very limited and available on a first come, first served basis. Preference will be given to exhibitors residing 20 miles or more from the fairgrounds. **Applications must be received by Friday, July 21, 2023.** Applications must be mailed or hand delivered to the Fairgrounds Office. No faxed or emailed applications will be accepted. **No exceptions.**
7. Camping permit is for RV Unit only and not to be used in any other vehicle. All other vehicles must have a proper vehicle pass or they will be towed.

We the undersigned, having read and understood the above, do hereby agree to abide by all the rules and regulations set forth by the Management of the Ventura County Fair. We also agree to hold free and harmless the Ventura County Fair and San Buenaventura State Beach, their employees, and volunteers from any and all claims of liability, injury or theft arising out of our use of the camping area.

MEMORANDUM

To: Fair Time Junior Livestock Campers Livestock
From: Department
Subject: Camping at State Beach, August 6-13, 2023

Camping privileges are limited to those who have a need in relation to their participation in the Fair. Camping at the Ventura County Fairgrounds is a privilege, not a right.

1. Junior exhibitors **will not** be allowed to camp without a parent or guardian present at all times. (For the purposes of camping privileges, the Ventura County Fairgrounds considers minors those under the age of 21 years.) Curfew - all minors are to be settled in the camping area by 10:00 PM unless under direct supervision of parent/responsible adult.
2. The drinking of alcoholic beverages is **strictly prohibited** in the camping area. This pertains to both adults and minors and subject to immediate dismissal from the camping area if violated.
3. First violation of any camp rule (except alcohol which is subject to immediate dismissal) will result in a written warning. Second violation of any camp rule is immediate dismissal from campground.
4. Pumping Services will be available at cost per camper per service. Payment for pumping service is to be made to the driver, sign up for servicing with Camp Manager the day before pumping service is rendered.
5. No open fires are allowed and only State Park charcoal barbecues may be used.
6. Remember camping is a privilege, not a right. Violation of any rule or regulation is cause for immediate dismissal from the camping area.

WE THE UNDERSIGNED, HAVING READ AND UNDERSTOOD THE ABOVE, DO HEREBY AGREE TO ABIDE BY THE ABOVE AND ALL OTHER RULES AND REGULATIONS SET FORTH BY THE BOARD OF DIRECTORS, MANAGEMENT OF THE VENTURA COUNTY FAIR AND STATE PARKS. WE ALSO AGREE TO HOLD FREE AND HARMLESS THE VENTURA COUNTY FAIR EMPLOYEES AND VOLUNTEERS FROM ANY AND ALL CLAIMS OF LIABILITY, INJURY OR THEFT ARISING FROM OUR USE OF THE CAMPING AREA.
